AU: Update to the National Industrial Chemicals Notification and Assessment Scheme (NICNAS)

The Australian Industrial Chemicals Introduction Scheme (AICIS) will replace National Industrial Chemicals Notification and Assessment Scheme (NICNAS) on July 1, 2020, as the new national regulator of the importation and manufacture of industrial chemicals in Australia.

Anyone who imports or manufactures industrial chemicals, or products that release industrial chemicals into Australia for commercial purposes must:

- Register their business with AICIS and pay a fee
- Categorise each chemical importation or manufacture into 1 of 5 categories
