Drayage Congestion Surcharge

Dear Valued Customer,

As you are aware, the past year has brought about unprecedented challenges for the transportation industry. Recently, it has reached a breaking point. As a result, international drayage carriers servicing several ports/ramps through the U.S. have implemented Congestion/Peak Season Surcharge.

The primary variables that are exacerbating the current market conditions include but not limited to:

- Congestion due to an extraordinary increase in import volumes throughout many US ramps and ports
- Loss of drivers to other industries and professions due to excessive wait times and loss of productivity at the ports and rails
- SSL rail embargos
- The South Atlantic and Central region chassis pool equipment availability consistently below sustainable levels.
- Labor and workforce shortages in the auto mechanic industry and back ordered truck parts cause servicing timelines to be extended for months.
- Extensive free time tying up equipment
- Carrier's pausing long haul or special equipment handling

Beginning September 1, 2021, a Drayage Congestion Surcharge at the rate of \$175.00 per container will apply to all U.S. inbound/outbound FCL cargo serviced through specific markets through the end of December 2021 at which time we will reevaluate.

What the industry hoped would be a short-term challenge is now forecasted to last well into Quarter 1 2022. Due to this situation that is beyond our control this fee will apply on door moves to/from the terminals outlined below. You can expect your C.H. Robinson Account Manager to keep you informed on the latest market conditions and communicate effective dates and levels.
