1. Introduction

This document is intended for business and technical personnel engaged in establishing an electronic connection with C.H. Robinson for the purpose of receiving Load Tender/Load Booking from Navisphere.

2. XML Structure

- Min (Use) and Max (Use) refers to the minimum and maximum occurrence of the field it describes. Min usage of zero indicates an optional field.
- Length indicates number of characters in each field.
- Required describes if the element is mandatory (M), Optional (O) or Conditional (C)
- Type describes what kind of data a certain element holds such as Variable Character, Enum
- Attributes are indicated in [brackets] and will be below the field it is located in.
- In the appendix there is a Enum.XSD with possible values for attributes

3.Load Tender/ Load Booking

This transaction set can be used to allow shippers or other interested parties to offer (tender) a shipment to a motor carrier including detailed scheduling, equipment requirements, commodities, and shipping instructions pertinent to a load tender.

XML documents must contain a root element. The **CHRLoadTender** element is the root element for the Load Tender Booking XML message.

Note: On our website there is an excel copy of this table, a test file, and XSD which will be easier for a BA or developer to work with.
