### List 2 Exclusion Extensions to be Considered

The Office of the U.S. Trade Representative (USTR) is considering extending the second set of List 2 exclusions for another one-year period. The exclusions are due to expire September 20, 2020. The USTR is requesting comments on the commodities due to expire and whether their exclusion should be extended.

Comments for Docket Number USTR-2020-0025 are to be submitted via <https://comments.USTR.gov>. The portal will open on July 1, 2020 and submissions will be taken until July 30, 2020.

The USTR is also considering extending the third set of List 2 exclusions for another one-year period. The exclusions are due to expire October 2, 2020. The USTR is requesting comments on the commodities due to expire and whether their exclusion should be extended.

Comments for Docket Number USTR-2020-0026 are to be submitted via <https://comments.USTR.gov>. The portal will open on July 1, 2020 and submissions will be taken until July 30, 2020.

### One Exclusion and 5 Technical Amendments Published

On June 24, 2020, the USTR added an exclusion previously missed and issued updates to several other exclusions. Certain motorboats were inadvertently not included in the exclusion list published May 28, 2020. Updates were made to the descriptions of parking stops of rubber, rail air brake hose couplings, mountings and brackets for railway air brake systems, retail computing scales, and ratcheting chain hoists.
